Because Rotary uses only volunteer workers to administer and deliver services, 100% of all contributions from *Friends* are used for charity.

# Benefits to *Friends*

*Friends* have the satisfaction of contributing to improve the human condition locally and abroad, addressing such critical issues as poverty, health, hunger, illiteracy, and the environment. They also benefit by knowing that Rotary carefully surveys the needs of the beneficiaries and selects projects that make the most impact to their lives, often in the form of self-help.

# Levels of contribution

The following yearly levels of contributions are available:

Platinum: \$2500 or more,

Gold: \$1000–2499,

Silver: \$ 250–999.

When making a contribution, *Friends* may designate a specific project, or leave this to be used un-designated with other contributions to the Rotary Club of Princeton Foundation\*. *Friends* make contributions through the Foundation to help fund service projects run by the Club. All contributions made to the Foundation are tax deductible.

\*The Rotary Club of Princeton Foundation is a non-profit organization chartered under IRS code 501(c)(3), and governed by a Board of Trustees.

# Current Club projects

All contributions by *Friends* are applied to:

**Community Service**, supporting the need for humanitarian assistance. Presently the Club is focusing on literacy; by providing dictionaries to Second Language students at the Princeton Adult School, and to 3rd graders in the Princeton Public Schools, and by giving thesaurus to each 6th grader of the Princeton Middle School, as well as providing a “First Library” for the three multi-cultural day care centers in town.

**International Service**, supporting health and well-being for needy populations throughout the world. The Club is currently the key sponsor for the District for Rotary International projects of health in Argentina, and clean water in Nicaragua.
